

# BNU 120<sup>th</sup> Anniversary 12 Months, 12 Offers Campaign

## **Terms and Conditions**

## Part I – Rebate Offer

- 1. The "BNU 120th Anniversary 12 Months, 12 Offers Campaign" ("Campaign") is valid from 1 January 2022 until 31 December 2022 ("Campaign Period"), both dates inclusive, with a different offer at a new designated merchant each month (please refer to Part II of these Terms and Conditions).

- 3. The Campaign is applicable for all BNU Credit Cards, but each offer is subject to the Credit Card acceptance by the designated merchants. Clients must check with the merchants beforehand.
- 4. BNU credit cardholders can enjoy MOP120 credit card rebate upon single net spending of MOP1,200 at the designed merchant of the month (please refer to Part II of these Terms and Conditions). The respective spending period is valid from the first day until the last day of each month.
- 5. The rebate will be given based on the Net Spending Amount of the Eligible Transaction reflected in the credit card account. "Net Spending Amount" refers to the final transaction amount charged.
